#### **CITY LIBRARIAN'S REPORT**

- 1. Role of the Alternate Board Member. Ordinance No. 2013-2381, Chapter 16.09.10 Alternate Members. In addition to regular appointments, the City Council may appoint an alternate member or members to any board, commission or committee. An applicant for appointments as an alternate member shall be subject to the same application and interview procedures as are applicants for regular appointments. Alternate members so appointed shall attend each meeting of the board, commission or committee to which they are appointed, but shall participate in a regular meeting only in the event of absence of the regular member. At such time as a vacancy occurs on a board, commission or committed, an alternate member is automatically eligible for appointment as a regular member, provided the alternate member is in good standing (e.g. good attendance record.)
- 2. Wells Fargo Mural Project. Wells Fargo recently installed a mural at their Highland-National City Branch using some of the photos from our Local History Room's photos collection. ## **Newspapers on Microfilm Digitization Project**

Microfilm records are unique in their challenges: poor quality images on the film, images missed in the scanning process, or data indexed incorrectly.

## 1. BMI Proposal (Jake Walker)

With Digital Reel, the microfilm is converted into a digital replica of the existing film.

- Each roll is scanned at 300 dpi grayscale: this feature allows users to adjust the contrast and brightness of every image for optimum legibility, ensuring the highest possible image quality.
- Each record will be OCR processed: this service provides global text-search capability over the entire microfilm collection. Highlighted hits appear for the searched word in the image View of the document.
- Digital Reel process: rolls will be transported to Sunnyvale, CA; will be inventoried and logged into their production tracking server to be scanned to Digital Reel. Throughout scanning, processed film images will be uploaded to their Digital Reel hosted server for immediate review/analysis by library staff. Scanning takes about 10 weeks.
- Included in the project is an access license to Digital Reel application that includes 5 users.
- Digital Reel cloud hosting: users can access records from internet-connected workstations.
- Features: issue date indexing + back up hard drive (1 PDF with OCR per issue) + hosted service the first year + project management (weekly deliveries)
- \$19,915

## 2. California Revealed (Pamela Vadakan)

- TIFF at 400 ppi, 8 bit grayscale
- Access copy for CA-R (jpg and PDF with uncorrected raw OCR)
- Access copy for CDNP (jpg 2000 and PDF with uncorrected raw OCR
- Reels filmed as two-page spreads and cropped to one-page per image
- Returnable hard drive
- Create XML files with descriptive and technical metadata. Upload to Archive.org
- If start the project September 2019 -> Summer 2020 as turnaround time (10 months)
- \$167,700

## 3. **Backstage** (Beth Ann Goodwill)

Backstage will scan the reels at 300 PPI 8 bit grayscale archival TIFF images. The scanned images will be processed using automated batch stings to split the two-page frames to one page per TIFF. Scanned images will be inspected by a QA technician for quality and to collect page-level metadata (title, year, month, day, and assign a 3-digit counter that starts over with each issue as well as the CA Revealed object identifier). Once the TIFF images passed QA, they will be used to create searchable multi-page PDFs with uncorrected OCR output, bound per issue.

The archival TIFFs will be used to create the CA Revealed tile set. A client-supplied metadata sheet is required for CA Revealed deliverables to be generated. CDNP files set can be generated upon request.

- The price quote is provided based on the assumption the reels are of good quality and suitable for automated post-scanning processing. If the quality of the filming is poor, special handling will apply.

- \$43,145 for 166 reels for 49 years from 1959-2008






