### **Kimball Senior Center**

- Kimball Senior Center attendance for January 2020 was 2,219.
- In January the San Diego Food Bank helped a total of 511 low income seniors with food commodity boxes.
- The Kimball Seniors Club and Casa de Salud Seniors Club both held New Year's dances that were well attended.

### Camacho Center

- In mid-December Camacho Recreation Center lost power requiring the facility to be closed for about a month. On January 13, 2020 the facility was reopened and it is temporarily being powered by a generator until the electrical problem can be resolved. Even with the outage staff were able to relocated and complete most programs.
- The new City Guide was released on February 3, with spring registrations beginning February 10. The spring season begins February 24 and ends May 3.

### **Las Palmas Pool**

Las Palmas Pool is closed for maintenance until further notice. Unexpectedly, the
electrical transformer malfunctioned leaving Las Palmas Pool with no power. Staff are
working on a temporary solution to provide youth swim lessons and adult/senior water
aerobics in the activity pool.

### Manuel Portillo Casa de Salud Youth Center

- For the month of January, Casa de Salud had a total of 222 participants.
- In January staff provided many fun arts and crafts activities, sports, video games and a field trip to the Fleet Science Center at Balboa Park.
