These uses require less staff time to process and 25% of the regular CUP fee is assessed. The Minor CUP came into effect with the reduction of fees authorized by City Council.

Maria Nix, applicant, stated that she has read and understands and can comply with conditions of approval. She stated in response to Commissioner DeLaPaz that she obtains her second-hand items from estate sales and no firearm sales will occur or pawn broker services will be offered.

Senior Assistant City Attorney

Senior Assistant City Attorney Claudia Silva updated that Commissioners on recent Council action to have the Planning Commission function as the Committee for Housing and Community Development. Two additional Commissioners will be appointed to serve along with the Planning Commissioners when items relating to housing project program and policies, housing loan assistance, and other housing issues require Commission action. Ybarra, Housing Manager, will introduce Commissioners to housing functions. Training will be provided to the Commissioners.

Principal Planner Peggy Chapin stated that the Planning Commission will also take on the duties of the Street Tree Committee.

Principal Planner Peggy Chapin stated a joint meeting of the Planning Commission and City Council will occur on October 20, at 5:00 p.m. regarding the General Plan Update. The background report will be provided in advance for the Commission review.

Principal Planner Peggy Chapin also stated the Westside EIR is nearing completion, with a draft document expected in mid-October. At that time, the Draft Westside Specific Plan and Draft EIR will be available and distributed to Commissioners for review.

Commissioner Flores asked if the City is pursuing new tenants for the former Circuit City site and Mervyns Store.

Principal Planner Peggy Chapin stated that a new retail center and housing development has been submitted for the current Sweetwater Crossing site, and a Hispanic Grocery Store has expressed interest to using the former Mervyn's site. Principal Planner

Commissioner DeLaPaz stated that Westfield has been a good operator and manager. Potential "big-box" retailers could be Fry's and Babies R Us. A restaurant used could be Olive Garden.

Principal Planner Peggy Chapin stated that the developer is Sudberry, with project partially in National City and Chula Vista, with Lowe's being in National City.
