Joan Rincon – Objected to a public member taking photos of speaker slips.

## Public Comments (3 minutes)

Georgia Torrence – Resident of National City, mother of 5 children; uses the library a lot; opposes the Drag Queen Story Time.

Rocio Hicks – Aware of somebody trying to make the Drag Queen Story Hour (DQSH) happen in our library; telling her family today she resents having to come down here and having to do this but it's her duty as a citizen of National City to make sure our values continue to be something we promote in our life; thanked the Board for all you do for the Library.

Consuelo Mayas – Resident of National City, takes children to the library and opposes the DQSH. John Moore – Resident of San Diego; enquired when the next vacancy on the Trustee Board will come up.

Andreas Wong – representing the Catholic families; request to make sure that the library has no sexual explicit books for kids and to continue with the cultural tradition of Christmas; enquired about the vacancy on the Trustee Board if it still open, what are the qualification requirements and application date.

Steve Hicks – Hate group in Alabama called The Southern Poverty Law Center smear Jews, Muslims, and Christians, attack immigrants, smear Mass Resistance and Ruth Institute because we are profamily; we have our eyes on those people who spent vast sums of money to promote the Sexual Revolution and trying to manipulate the government behind and against the vast majority of people.

#### **BOARD TRUSTEE COMMENTS/COMMUNICATION**

- Trustee Bang -
  - Does the Library have a loan grace period policy for library materials? Trustee Bang had a book due January 6<sup>th</sup>. Since the Library and the book drop were closed during furlough, he did not have the option to return it before the due date and was not able to return it on the day the Library reopened. Trustee Bang suggested the Library to consider allowing a loan grace period for library materials lent out.

- Reiterated the reason he brought up the matter of the Drag Queen Story Hour was because there was 22 trans-genders killed last year and countless people committing suicide

because they chose to live their gender choice and the way the society treats people like that; and because the Library is a good place to have this discussion on the DQSH and the issues that are brought up there. He listened to all who expressed and feel strongly about their opinions even though he doesn't agree. By having this more civil discussion, we're listening to what's pushing the other side's opinion and can get a better understanding and agreement on what would be the course forward.

- Trustee Juarez thanked all the members of the community who have come out to attend the Library Board meeting and share their comments.
- President Godshalk congratulated Trustee Howrey-Colmenero and Alternate Trustee Moon on their appointment to the Library Board.
