1. ITEM NO. 2019-01

REQUEST TO INSTALL “NO TRUCK PARKING” SIGNAGE ON THE EAST SIDE OF CLEVELAND AVENUE, BETWEEN W. 22ND STREET AND THE DRIVEWAY OF THE PROPERTY LOCATED AT 2143 CLEVELAND AVENUE

Mrs. Margaret Godshalk, resident, was present to speak on behalf of this item.

Mrs. Godshalk stated semi-trucks are parking in front of the residences and they are noisy and unsafe. She says they are also parking over painted designated parking spots taking up multiple spaces.

Ms. Carla Hutchinson, Assistant Engineer– Civil, provided the staff report for this item.

Committee Member Coyote Moon asked Mrs. Godshalk if the trucks have alternate parking available. Mrs. Godshalk responded that Dole has their own parking lot.
