1. ITEM NO. 2018-21

REQUEST TO INSTALL RED CURB “NO PARKING” AT THE INTERSECTION OF E. 24TH STREET AND “J” AVENUE IN ORDER TO IMPROVE VISIBILITY AT THE INTERSECTION

Mr. Luca Zappiello, Junior Engineer – Civil, provided the staff report for this item.

There was no public opposition to this item.

Action: Motion by Moon, 2nd by Coyote, to approve to: 1) install 20 feet of red curb “No Parking” on the west side of “J” Avenue, south of E. 24th Street. This will result in the loss of one (1) on-street parking space; 2) install 20 feet of red curb “No Parking” on the east side of “J” Avenue, north of E. 24th Street. This will result in the loss of one (1) on-street parking space; 3) install 10 feet of red curb “No Parking” on the west side of “J” Avenue, north of E. 24th Street. This will not result in the loss of on-street parking space; and 4) install 10 feet of red curb “No Parking” on the east side of “J” Avenue, south of E. 24th Street. This will not result in the loss of on-street parking space.

REQUEST TO INSTALL 20 FEET OF RED CURB “NO PARKING” ON THE EAST SIDE OF NATIONAL CITY BLVD., NORTH SIDE OF THE DRIVEWAY ADJACENT TO 2829 NATIONAL CITY BLVD. IN ORDER TO ENHANCE CLEARANCE AND ACCESS ONTO NATIONAL CITY BLVD.
