Vice Mayor Rios commented on City Clerk Dalla's comment regarding the need for the name of the 24<sup>th</sup> Street Trolley Station to be corrected since it is no longer on 24<sup>th</sup> Street and she offered suggestions for residents to conserve energy to avoid blackouts.

Mayor Sotelo-Solis thanked the community for saving energy; encouraged people to volunteer to assist at food distribution centers and expressed appreciation for George Baca's contribution to the community as well as to the Baca Family.
