As owners or employees of area businesses and/or people interested in the Downtown Specific Plan we would like to make these recommendations to the Mayor and City Council

- 1. We request immediate Automobile Only Parking be provided on Roosevelt from 1<sup>St</sup> to 4th Streets and Truck Parking only be allowed in front of the motels. "No Truck Parking" Signs should be put up on Roosevelt and on the side streets: 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> from Roosevelt to NC Blvd.
- 2. In Zone 1A we are in favor of maintaining the FAR of 6 Unlimited Height (the original plan designation and not FAR 3-6 or any other lower designations or height limitations of 130' presented at meetings. In these 5 Blocks there are owners interested in joining together to make viable projects and this is the Northern Gateway to the City. It also does not back on single family housing, has stable soil that affords underground parking construction and has freeway and ocean views. So it is the area most likely for development to occur.
- 3. We would like the City to consider amending the "Grandfather Clause to allow businesses to occupy the east side of National City Blvd from 1<sup>st</sup> to 7<sup>th</sup>, either as a zone change or a 5 year conditional use permit.
- 4. Please maintain the FAR of Brick Row and Historic Buildings on A Street from 8<sup>th</sup> Street to Plaza. These buildings now have a FAR of 3-4 and should be able to sell their Air Rights to help maintain their Historic Buildings.
