Allowing your constituents to rent out their main home and live in the ADU will dramatically increase the median income of the homeowner. An example of a prohome owner regulation would be to reduce or eliminate permit fees for CURRENT owner occupants. These small changes will allow current residents to have a large investment advantage compared to outsiders. The end goal is that we want our residents to be financially free and to grow. Public policy should encourage this.

On behalf of the YIMBY Democrats of San Diego County, please accept this letter in support of the proposed ADU ordinance.

The San Diego County region faces many challenges - climate change, housing affordability, and accessible transportation. As advocates for sustainable growth, equitable public policy, and housing affordability, we believe that the creation of accessory dwelling units (ADU) is an essential piece of a larger housing framework that can help alleviate the state's housing crisis.



It is a model of a national campaign to the "New Green Deal" in its early stages.



Good afternoon Mayor Sotelo-Solis, Vice - Mayor Rodriguez, and City Council Members Mona Rios, Marcus Bush and Ron Morrison,

My name is Silvia Calzada, a constituent of National City currently living in the Paradise Creek Apartments, a part of the WITOD project.

As a resident leader, I am requesting you DO NOT rename the park well-known as the **Paradise Creek Educational Park, neighbor of the** Paradise Creek Apartments.

For many years, the park has been recognized under this name and referred to as such in the FINAL Westside Specific Plan dated March 2010, Focused General Plan Update dated August 2020, and in various other resources. Committed members such as Kimball School teachers and Westside residents have dedicated their time and efforts to rejuvenate and protect Paradise Creek's environmental value and its ecosystem, and used this opportunity as a tool to educate and promote to anyone open to learn and appreciate the beauty of this treasure in our City.

I recommend that if there is to be a name change, then there should be an open space of communication for community members to share their thoughts and ideas through a workshop or such. This will be a perfect opportunity to practice one of your core values to "communicate openly, honestly, and with clear, consistent messages." And if this is not an OFFICIAL title, legally recognized, then this is the time to inform and recognize it legally in due time.

One last request is to please follow-up and investigate why Paradise Creek Educational Park does not exist on the 911 Dispatcher maps. A few months ago, the 911 Dispatcher informed me the park does not show on the maps used to support emergency calls.

As much as I love and respect Dolores Huerta, a beloved latina leader, for her work and advocacy in labor and civic rights for the people, I feel that the work and love behind this park deserves it's own credit through the legal name as **Paradise Creek Educational Park.** Thank you.

Public comment for Item #20 from Mr. Ted Godshalk

Council,

There is universal agreement that Delores Huerta is a living hero and that her achievements deserve recognition. That is not at issue here.

# Paradise Creek Educational Park is the connective link that ties our community from Paradise Hills in the northeastern corner to the south west at Paradise Marsh and San Diego Bay. The place name always came first.

The salt marsh habitat is very rare in California and the world. Paradise Creek has been a stimulus for many grants and new enhancements, worth many millions of dollars. Removal of tons of toxic soil and some flood control, the building of affordable housing, a new Harding Ave., and the new recreation all came about because, first there was protection of Paradise Creek. Can future improvements be gained with less recognition or connectivity?

This park is an Outdoor Laboratory and Classroom. It has Educational in the name because the group of community members, parents, and teachers who worked hard to get the approvals for the park in the 90s believed that everyone can learn from being involved in the effort. That has proved true over and over. We work with schools of all levels from Kinder to College to provide important environmental education. Our neighbors seek relaxation and knowledge at this park. Please pause and ask yourself: what is the lesson here?

Our non-profit organization holds the very valuable *institutional memory* for this project, and I can remind you that this park was dedicated in 2007 with a City Council and community ribbon cutting. The name has been cited in the news, in city grants and public outreach, and by other involved organizations in their supporting work.

With all of that in mind, we believe that the park should remain named as it has been known for the last 25 years. The City Council should be aware that this is how the volunteers, community members, parents, and students feel about their involvement and achievements.

One better idea is that the City Council could make a study of the many places and buildings in National City that could be renamed to honor someone today. *Always start with a proper and respectful discussion with community members*. Listen to them. A few suggestions going forward for study are:

• The new Harding Avenue segment above the park.

- Coolidge and Wilson Avenues, named for U.S. Presidents with racist backgrounds who would not be recognized today.
- Also, the City could work with the Port District to rename Pepper Park.
- Or the City could work with the National School District to rename two Schools named for former school principals, John Otis and Ira Harbison, after someone notable and memorable.
- Simply put, the City can change Las Palmas or El Toyon parks to recognize the important people of our time, or rename City Hall, Las Palmas Pool, the former Library or the current Library, or another city building.
