My name is Alex Neu, I've been a National City employee for 3 years at the library. I'm an SEIU Local 221 member and bargaining unit member.

Last council meeting you heard many employees voice their concerns and frustrations with National City as the city continues to fall behind in paying their employees competitive wages. As we negotiate on the upcoming contract to bring our members a contract that is fair and comparable to that of surrounding cities, the City is not making an earnest effort to bring us up from the bottom.

The city hired a consulting company to conduct a salary survey and the results show that National City pays MEA employees 15% below the median on average. I don't see why the city would go through the expense and effort of a salary study which proves that they underpay their hard-working employees, only to make minimal effort to adjust the compensation accordingly. This demonstrates that the city has very little respect and appreciation for us. This has huge ramifications that impact morale, attrition, productivity, and quality of work.

Cost of living and inflation keep going up but the employees just keep fall further behind. We are fired and fed up of being at the bottom. We keep this city running and deserve fair wages. It's time to do right by your employees.

My name is Steven Moss. I am a proud SEIU 221 member and I have worked for the City of National City for six years with over thirty years in my profession. I serve the residents of National City with the work I do as a Police Dispatcher at the National City Police Department. As many SEIU 221 members told you last week, the city is suffering because National City Is falling behind in the wages it pays to employees. As Police Dispatchers, we are one of, if not the lowest, paid law enforcement dispatchers in San Diego County. We are severely understaff in Police Communications at NCPD. We have been working 12 hour plus shifts for over three years due to staffing shortages. As you may be aware, we are contracted to work four ten hour shifts. We are losing experienced 911 Dispatchers because dispatchers are having to make the choice of constant overtime, low wages, no breaks or lunches and being separated from our families with few days off a week. Morale is very low in our department due to understaffing and low wages. I was recruited to NCPD and have over thirty years experience as a police dispatcher. In 2018 I was awarded the Centurion Award by the National City Chamber of Commerce. But now, I am forced to consider my options as National City is no longer competitive pay wise and other public safety departments are being able to staff their departments through competitive pay and better working conditions. We are asking the City to invest in us with equity adjustments that make National City competitive with similar cities across San Diego County.







Kathleen Lippitt here, as a public health practitioner I have advocated for sound public policies that allow children to grow up in a healthy and safe environment that supports their good decisions for over 20 yrs.

Permitting frees are intended to cover the cost of permitting commercial marijuana businesses, but please remember Imperial Beach set their one-time fee at \$1.5million. The marijuana retailer applicant didn't bat an eye knowing that fee would be minimal compared to the profits he stood to make.

A recent article in the Guardian highlighted many of the adverse outcomes from attempting to permit and regulate an industry that profits from drug abuse and addiction that should be seriously considered.

For the last 5 yrs local governments have been trying to close the barn door Prop 64 opened. Contrary to the industry's message that regulations will ensure the black market would be eliminated, children would be protected, products would be safe, and any and all regulations imposed on the industry would be happily accepted. None of those promises were kept. The industry has and will continue to litigate on behalf of weakening or eliminating regulations and ultimately reducing or eliminating the tax revenues you once made a Faustian bargain to accept in exchange.

Experts now report 80-90% of the MJ market remains underground. Logically, illegal businesses should have been closed BEFORE permitting began. Legal businesses were expected to help close illegal businesses, but they lacked not only the motivation but the deterrent effects of consequences and law enforcement resources. Consequently, the illegal industry has grown exponentially, flourishing, and using their massive profits nefariously to influence local, state, and federal government officials and the regulatory

support infrastructures behind them. They've also led permitted operators back into the world of corruption from which many of them came. With massive profits they began to purchase legally permitted businesses.

Today state-licensed businesses say they must keep one foot in the illegal, unlicensed market to stay profitable. But their claims of financial suffering are neither documented nor supported by evidence. No longer tenants, they've become landlords of expansive, sophisticated premises that have and will displace existing valued community businesses and resources. Their influence and ability to amend or adopt policies or ordinances to grow their industry is a betrayal of your promises to serve the welfare of your youth and families.

Unless you believe that your children, families, and vulnerable communities will benefit from commercialization and normalization of marijuana and the influence they will exert upon your children to begin using and abusing marijuana, exposing their developing brains and risking their long-term life goals, you should staunchly oppose and restrict the ability of this industry to exploit your communities, especially your low income and communities of color. Their success will come at the expense of your children and communities.

My name is Greg Boeh. I am the C.O.O. of GB Capital Holdings and am responsible for the management of Pier 32 Marina.

I am here to speak in favor of Item #31 granting the conditional use permit to San Diego Rescue Mission to add a transitional housing facility as an approved use.

Let me first share with you my experience with San Diego Rescue Mission in their downtown location. This location is located four blocks from a home that I own. Having lived in the area and managing the Cruise Ship Terminal I was concerned about the San Diego Rescue Mission moving into the neighborhood. We had many homeless persons that would migrate between Balboa Park and the Bay. Encampments were part of our normal lives and certainly the Rescue Mission would make this worse. This site was in my path of frequent travel.

Pleasant surprise, the project was approved and rather than an increase of persons who are homeless near the area we witnessed a decrease. The area around the site has been kept neat and orderly and appears to be well managed. The facility has helped manage the area in a responsible manner.

Currently our property in National City, Pier 32 Marina, has experience the effects of persons that are homeless, living in the Sweetwater Riverbed, and transiting the Marina. Between the cost of living in San Diego, Mental Health Services, and lack of life skills we have seen they population grow.

San Diego Rescue Mission helps bring justice for those who have been less fortunate than my own family. They help get people off the streets and back into society. Their mental health team gives these people the opportunity to succeed and feel proud.
