Good afternoon Mayor Sotelo-Solis and City Council members.

My name is Danny Serrano, and I'm providing comments on behalf of EHC. I'd first like to really thank Commissioner Secretary Naranjo for helping to adopt a strong Maritime Clean Air Strategies (MCAS). I'd also like to thank Port staff for all their work, thus far, in making progress in implementing the MCAS and for providing an update to the Council on 2/1/22. Heavy-duty trucks and cargo handling equipment at the National City Marine Terminal, for example, represent roughly 14 percent of cancer risk to National City per the Port's draft Health Risk Assessment. Implementation of the MCAS (such as the full transition of heavy duty trucks and cargo handling equipment to zero emission by 2030) will help to address the severe air quality issues that west National City residents experience in large part because of maritime industrial operations.

One of the challenges to implementing the MCAS, as with any important policy document, is limited funding. Although Port staff have already worked hard to secure state dollars to help implement some MCAS policies and are developing an elasticity study to consider new fees, much more funding and information will be needed. For example, at this point, it is unclear what the total cost of MCAS implementation would even require over the next five years. It is necessary to project future costs of policy implementation in order to understand what the funding solution needs to be. There remains a need to develop a comprehensive funding strategy for all of the MCAS implementation.

While it remains unclear exactly how much funding is needed, it is clear that the Port will need to find additional ways to increase the number of grants and other funding sources (e.g., Governor's request for \$6 billion in the state budget for heavy-duty zero emission vehicles, Federal 2021 Port Infrastructure Development Program Grant Awards etc.) to help pay for the implementation of the MCAS. One strategy for the Port's consideration is to determine the estimated costs for MCAS implementation measures over the next five years while creating a more transparent way of tracking the Port's efforts to align funding (such as grants, fees, etc.) to implementation. Port staff should also clarify how various funding sources are aligned with specific MCAS implementation strategies. EHC looks forward to working with the Port and National City to look at creative ways to develop funding mechanisms to implement the MCAS to benefit Portside Community residents.

EHC is asking that the City Council consider requesting the Port to take the following actions:

- Develop a comprehensive strategy to fund the implementation of the MCAS and incorporate the City of National City in this effort for any possible bilateral funding opportunities.
- Make quarterly updates to the National City Council on all available funding opportunities for the MCAS, how various funding sources are aligned with specific MCAS implementation strategies, the status of the Port's efforts to go/no go funding opportunities, any potential City/Port

bilateral funding opportunities, and progress towards addressing the funding needed to implement the MCAS.

EHC is looking forward to further collaboration with Port staff to help implement the MCAS and achieve health equity in National City. In order for EHC and others to track the implementation of the MCAS, we need the Port to develop a comprehensive MCAS funding strategy that is publicly available along with regular updates to the Portside Community stakeholders such as National City.
