

While several maps merit discussion, Map #1 by APAC presents the greatest opportunity for equitable representation amongst all demographic groups.

Beyond the consideration of pure numbers, the APAC map clearly creates a unified corridor of residents and businesses. To consider separating like establishments along Plaza Boulevard would be antithetical to this process. While any separation is imperfect, a tenet of districting should be to create a balance of population centers that offers the widest diversity of representation. In the letter sent by Atty de Castro after the last community workshop, there is also the appearance of Mayor Sotelo Solis favoring the map submitted later and with less favorable API CVAP numbers because it was from her cronies, of whom one sits in her advisory committee.

If the goal is indeed to further strengthen the FilAm / API vote in a district voting, it is more reflected in the Public Submission # 1 - the APAC Map. I urge you to adopt this map.
