Public Comment for May 17 from Mr. Ted Godshalk

Council,

The recent budget discussions did not go far enough to recognize the public and their input gathered. Choices suggested by the staff were ranked by the public. As we had to work with what was listed, it is no surprise that the final list did not include many new ideas from residents. The bathroom at PCEP is the one exception, and congratulations to the advocates for that suggestion.

The survey's recommendations were subverted to propose some concepts over others. Items ranked three, six, and seven were shuffled to the bottom of the list so another 1.25 million dollars can follow the 10 million dollars you have already set aside for Las Palmas Park.

Please look closer at item three. It deserves more attention. When people say they want the city to spend a million more dollars on streets, they are really asking for more action on quite a few issues.

Street problems include:

inadequate traffic safety striping,
speed limit enforcement,
trash in the parkways and gutters,
broken sidewalks,
inadequate landscape and maintenance of existing trees and weeds,
traffic signal repair,
signage cleaned of graffiti,
continued maintenance of lighting, and
speedy asphalt and pothole repair.

Yes, you were told that there is a different pot of money to spend on these things, but the SANDAG and Gas Tax money has not met the increasing needs we see in National City. The people who voted for streets in the survey can be given the credit they deserve for their understanding that you already spend SOME money on streets. They told you that you need to do more, and spend more, on streets.

Please give ranked item 3 more priority. Pulling the money from lower ranked Las Palmas expenditures will show that you instead take the view as Mrs. Rios once clearly said, "I would like to see quality of life improvements..." included.

Good Evening City Council members. My name is Marisa Rosales, I am a resident of National City, a member of the United Lowrider Coalition and a Commissioner on the Traffic Safety Committee.

On May 6<sup>th</sup> the United Lowrider Coalition held its inaugural permitted Cruise Night on Highland Ave. The event was a highly attended, successful event with a positive atmosphere. Due to the initial high attendance of the event the National City Police Department is placing numerous requirements for the next cruises which are, to pay for officers presence at a cost of \$8,000.00 dollars, Public works signage, Caltrans signage, and for a private company to create a traffic plan for a total cost of \$18,000.00 dollars per cruise, which will add up to \$90,000.00 dollars for the remaining 5 cruise nights. The police requirements are based on the attendance of this one event, which was highly publicized in the media, was on 5 de Mayo weekend and was to many in the community a historic event.

I believe the police department requirements are premature. I am certain that the following cruise nights will not be as attended as the inaugural event, now that the buildup of the event has passed. The City should grant the United Lowrider Coalition a grace period prior to imposing requirements that are extremely costly and basically unattainable, this grass roots organization cannot afford this overhead.

For this pilot that the City agreed to support to work, we must truly share the responsibility. If the City imposes these requirements, then the City is basically shutting the event down. I plea to the City Council to hold off, wait to see what the attendance of the next two cruises are prior to imposing additional requirements.

Honorable Mayor and Council,

My name is Jovita Arellano. I'm a member of the United Lowrider Coalition. Due to a previous commitment, I'm not able to be on this zoom meeting.

I want to thank you for approving our TUP for the Cruise Nights on Highland Avenue. Our first cruise in my eyes and others that I have spoken to, despite some hiccups was a highly successful event.

The United Lowrider Coalition (ULC) met with NCPD and are now required to pay almost \$8,000 plus in fees per cruise to the police department. We had 6 scheduled and approved for this year as a trial run.

The original Temporary Use Permit that was granted to us came with no fees along with permission to host these cruise nights, but now they want us to pay \$8000 plus per cruise to include fees from Public Works and Caltrans for signage along the 54 freeway and on Highland Avenue.

We, the United Lowrider Coalition is an all-volunteer group. Our goal is to repeal the "No cruising" ordinance in National City. We don't have the funds to pay any new required fees.

The NCPD told us that there were numerous calls for service the evening of our cruise on May 6<sup>th</sup>. I received the calls for service from NCPD and yes, there were 52 calls for service. But only 8 calls for service were related to Highland Avenue. Calls were for Special Detail, Traffic Stops, Non Injury, Disturbance and Parking.

I personally asked two officers for help that evening and was refused any service. Yes, we said that we would self-police. But we were also told that if needed, there were double officers on duty on Friday's.

When we began this process of applying for a TUP, we were told directly by the Chief of Police that we would not have to pay anything at all due to the fact that there were double officers assigned each Friday. We were also told that if we needed them all we had to do was ask. That clearly wasn't the case on Friday, May 6<sup>th</sup> during our cruise.

We have worked very hard up to this point with our members, elected officials, law enforcement and the businesses along Highland Avenue. To put us in a predicament at this level feels like discrimination against us. We all want to be able to enjoy the cruises that are still scheduled for the first Friday of each month ending in October. If required to pay the fees we will be unable to have any more cruises.

I'm asking that the City of National Mayor and Council use their resources to help pay for these fees.
