Council,

Tonight, the budget is being presented in a manner that is completely acceptable to staff. At the May 17 council meeting, Mr. Raulston stated that the PowerPoint slides were available for the public to study, but he has not included the slides tonight for the public, **nor even for you** to study. Is this really because we are supposed to forget how the line item figures have been derived?

The add- ons "Council Direction Items" in last meeting were not officially adopted into the budget and it looked like there would be more discussion tonight. There needs to be more discussion tonight before making decisions. But the slides are missing.

Holding this item during a virtual meeting is further proof that the virtual process is now your acceptable way to deal with important issues. It is much easier to manage the issue and, in fact, hide discussion points.

We are left to wonder if the amount budgeted for the four new employee positions. At over \$560,000, you should be doing analysis to see if these salaries and benefits are appropriate. THE SALARIES SEEM HIGH.

The Principal Planner level for the EJ position is too high and will result in upward pressure on the salary of the Planning Director and then ripple through the rest of the upper management.

Have you checked to see if the Code Enforcement officer \$106,000 is the right salary?

Does the new Homeless Coordinator warrant a salary package of \$144,000?

Have you considered that the National School District can handle after- school programs during the school year and the City could provide more robust Summer and Spring Break activities that build a culture of year-round learning, fitness, and community service?

This budget discussion should be continues to the next meeting so there can be a more educated decision.
