Comment for item 8.5 on the Consent Calendar of the meeting of August 15, 2023 from Mr. Ted Godshalk.

Please pull the item 8.5 of the Consent Calendar to discuss the item.

Once again, you should not chase a grant opportunity to meet a project that is not clearly planned. Go ahead and accept this grant but the sites identified in the staff report should be carefully thought about before acting. Just because all of the properties in the report are city-owned and zoned residential, not all are appropriate for housing.

The city-owned property identified as Site 4 in the Housing Strategic Plan and in this agenda item is unsuitable for sale and use as housing. Let's look at the facts. You, and previous City Councils, have endorsed the idea of Transit Oriented Development. You have plans to change the density in single family neighborhoods. The property along Plaza Bonita Center Way is rural in nature and is very near the county line. If you approve housing in this area you would be encouraging *Suburban Sprawl*.

There are additional constraints to consider. The property has an unsuitable topography for housing. Housing in this location would encourage more automobile trips along already congested streets and freeways. Building in this location is contrary to the Climate Action that we have demanded the City of National City take. You can help the housing shortage in our region by taking other, less economically expedient steps like planning housing for the Trailer Park/ Drive-in location along National City Blvd.

If you tell us that you believe in Inner City high density <u>and Suburban Sprawl</u>, then we have to really consider whether you honestly care about either one. To summarize, to encourage housing at Site 4 in this report would be irresponsible and hypocritical.

I recommend that you reserve this parcel for a mitigation of environmental effects somewhere in the city or county. The property has value in this form. Of course, the use as a park would be beneficial, as well. The open space value here is very important.

Public Comment for City Council Meeting item 8.9 on August 15, 2023 from Mr. Ted Godshalk.

Please pull the Consent Calendar item 8.9 for discussion. My comments are included below.

First some questions: The staff report states that a review was done in 2021 and that ten policies required minor clean-up. Why did it take two years to get to this update action? According to City Council policy, an update is to be done in October of each year. Why has this set of updates been scheduled now? Will there be more updates in October? Why have some current policy "clean-up" items been missed?

While most of the staff's changes are clerical or related to punctuation, there are several new changes I suggest here, since you're updating policies now.

## Policy 104 II E. #1- Responsibilities of the City Manager

ADD- The City Manager shall provide a written report at each City Council meeting. The report will become part of the approved minutes.

#### **Policy 104. VI. C. 2.** Combine points a. and b. with new language-

If the number of speakers for any item, including "Public Comments" and other Agenda Items is ten or less, then each is allowed 3 minutes. "In-person" speakers will go first, followed by 'Call-In" speakers, followed by "Written" speakers (submitted by paper copy, email, or e-Scribe). Written comments will be read into the record for three minutes if there are a total of ten or fewer speakers.

If the number of commenters is more than ten, then no written comments are read into the record. "In-person" speakers go first, with "Call-in" speakers following, all with a two minutes time limit. Any written comments that are similar in content, or appear as a "form letter" may be summarized by topic and name of the sender.

At 30 minutes elapsed time on any one agenda item, the mayor may decide that all remaining speakers will be held over to the end of the meeting and the item is then moved on the agenda to the point after all "Staff Reports" items are concluded.

The City Clerk will declare and record any request to remove an item from the consent calendar. All procedures for speakers will be the same as above.

## Policy VII. N. Staff Reports

ADD- The City manager shall provide a written report at each City Council meeting and the report shall be included in the minutes.

# **Policy 106- Minutes**

ADD to second paragraph- The portion of the City Council meeting devoted to staff, Mayor, City Attorney, and City Manager shall consist of a brief written description of the subject matters and actions taken and shall be included in the minutes.

CHANGE the third paragraph to read- Public Comment, Consent Calendar, and Public Hearings will include a list of all people speaking to the time and a summary of their position or comments.

#### Policy 107-

**ADD to the Appointments section- and new "A" section** and move all other sections downward.

ADD- A vacancy on the City Council shall be filled with the appointment of a resident from the District which has the vacancy. The applicant must prove current residency of more than two years. The Mayor will conduct the interview process within 60 days of the vacation of the seat. A simple majority of the voting City Council is required to appoint a person to fill the unexpired term. The Vice Mayor will assume the role of Mayor if the Mayor's seat is vacated and then conduct the interview process. If the Vice Mayor is unavailable to hold the office of Mayor then the City Council shall appoint the Council member with the most years of office.

# Policy 108-

ADD- The City Manager shall submit a written report to the City Council and the public at each City Council meeting.

#### Policy 114

ADD- in the second sentence change, "On a periodic basis..." to On a quarterly basis, the City Manager will provide a written report of all grants pending,
awarded, and acted upon with contracts to the City Council and the public.

#### Policy 120

ADD- **Section 6-** - The rotation of Vice Mayor must not include a representative from the same district with the previous two years.


