Public Comment from Mr. Ted Godshalk for February 6, 2024:

Council,

First, the request made to the council for information about the New Year's Eve explosions in our community has not been answered on the record as of tonight. The community deserves to know about the extent and location of the activity and the police response. Please ask again for a report.

Second, when the formal question during Consent Agenda was posed to the City Attorney to provide an explanation for the \$44,000 expenditure to the outside law firm of Devaney law firm, the City Attorney responsed that he would look it up. He did get back to me, but did he also get back to you? You were authorizing the spending.

A portion of the spending went towards the city's defense against the Cannabis companies' lawsuits. Tonight there is more spending with this firm. Do we continue to pay *Cali Mota* and Devaney for the decisions you made to sell weed in our city? Be honest and talk about it with the community at Council Meetings and at your District neighborhood events.

It looks like you may be approving spending you don't have full information on at the time of voting. Or you have the information and don't tell the community. That is troublesome.

Third, I have had conversations with both Mr. Parra and Mr. Amatee about the need for the residents of National City to have training for disaster preparedness and response. It goes deeper than the CERT team. This planning for our survival of natural events should happen through Neighborhood Councils and the need is more evident than ever. What will the City propose tonight for the future well being, the resiliency, of our residents?

Lastly, as a Director of the non-profit organization Paradise Creek Educational Park INC., I will be working this year to design a project for the basin at 18th Street between Hoover Avenue and National City Blvd. This project will counter the misguided TODO plan with smart retreat, pedestrian trails, and a new expanded wetland basin that can help manage big storms and high tide events, provide the resiliency we need, and improve our community quality of life.

This is a time when **you** must do your best work, **be inspired and sincere**, and act with a **sense of urgency** for homeowners, renters, and business interests.
