

#### FLOOD SURVIVOR PROPERTY TAX RELIEF



- Must file within one year of the Governor's January 21-23, 2024 declared Winter Storm calamity.
- Must have at least \$10,000 in property damage.
- You do not have to know the exact damage amount to apply the application is easy, and we ask for exact estimates later.
- **❖** Tax relief is available for boats, planes, and business equipment.
- ❖ The property tax reduction is temporary, and taxes are restored to its original Prop 13 protected amount when the property is rebuilt to its same pre-disaster state.

# PROPERTY TAX RELIEF DEFERRAL APRIL 10<sup>th</sup> PROPERTY TAX BILL



- ❖ After a Governor-proclaimed disaster, qualified recipients may request property tax relief and have their next regular property tax bill deferred.
- Homeowners qualify if they have at least \$10,000 of damage to their primary residence.
   Homeowners <u>do not qualify</u> if using an impound account.
- ❖ Non-primary residence (ex. commercial, multi-family, agricultural) property owners qualify if damage to their property is greater than 20% of the pre-disaster market value.
- Must file an application for "Reassessment of Property Damaged by Misfortune or Calamity" either previously or concurrently.
- ❖ Must file by 5 pm on the April 10 or December 10 tax filing deadline following the disaster.
- ❖ The deferred property tax payment comes due 30 days following completion of the home or property repairs. Our office is notified by completion of a final permit.
