# 2024 MISS NATIONAL CITY EDUCATION PAGEANT

## Qualifying Rules and Regulations

1. A contestant must be between the ages of 17 and 24 and not yet 25 by June 1, 2024. If a contestant is 17, the contestant must be a senior in high school. The contestant must be of good moral character. The contestant must complete a background check and not have any criminal convictions. The contestant must commit to attending school during the 2023-2024 school year.
2. The contestant must be a resident of National City at least four (4) months prior to the Miss National City Pageant. Residency is based on home address. Please submit a copy of your current driver's license or CA I.D. along with the "Official Qualifying Application" to the Miss National City Liaison. If chosen as Miss National City or Royal Court, you must maintain physical residence in National City throughout your reign. If chosen as Miss National City or Royal Court and you choose to reside outside of the City of National City during such reign, the City of National City has the right to remove all crowns, titles as well as any scholarships, gifts, or prizes that you have or may receive.
3. The contestant must not have appeared nude in any photo, movie, video, publication, social media, or any internet site, and must agree not to appear in such during the year of the reign. Also, if you are affiliated with any type of groups, clubs, or affiliations that would reflect poorly on the City of National City's image, you may be disqualified from participating in the Miss National City Pageant.
4. Falsification of any fact on the "Official Qualifying Application" will disqualify a contestant from further participation in the Miss National City Pageant.
5. Contestants will be judged on poise, personality, public speaking, resume, interview skills, business attire, and a community project, along with impromptu questions on stage. The contestant will be responsible for all costs during their participation in the Miss National City Pageant.
6. The contestant will take part in all rehearsals and appearances as scheduled by the Miss National City Liaison. All appearances must be pre-approved by the City of National City and you must maintain open communication with the Miss National City Liaison.
7. The contestants must coordinate with the Library & Community Services Department to attend the 10 rehearsals.
8. Contestants may not compete in the Miss National City Pageant if the contestant has been a past Miss National City Queen.
9. If chosen to be Miss National City or Royal Court, family members, friends, acquaintances, or significant others may attend city functions, parades, or special events but must remain in the background and cannot be part of the event. If a chaperone is required, only an adult family member may chaperone.
10. The Contestant agrees to defend, and hold harmless the City of National City and the Miss National City Pageant from and against any liability, claim, loss, or expense including reasonable attorney's fees arising out of any injury, claim, or damage which is caused by or arises from or is any way connected with participation in this program or event.
