#### **PRESENTATION**

2. Presentation on Brown Act. Presentation by Senior Assistant City Attorney Claudia Silva.

Senior Assistant City Attorney Claudia Silva made a presentation to the Planning Commission on the Brown Act. She responded to questions of the Commissioners concerning maintaining a written list of discussions with members of the public, both on pending items but prior projects as well, and identifying those contacts at the Commission meeting.

Commissioners thanked Ms. Silva for her presentation.

#### PUBLIC HEARING

3. Public Hearing – Conditional Use Permit to operate a sign shop in an existing building located at 416 National City Boulevard. Case File No. 2010-02 CUP.

Mario Rodriguez, 416 National City Boulevard, applicant, responded to Chairman Baca that he has read, understands, and can comply with all conditions of approval.

Commissioner Alvarado asked about the business, stating he noticed t-shirts at the store.

Mr. Rodriguez stated that they have a business in Chula Vista. This store will operate as a retail store selling signs already made. On occasions they will print t-shirts for customers. No more than two machines will operate at a time. The primary business will be selling flags and banners.

Chairman Baca confirmed with staff that there will not be an issue with parking at the site, or with noise. He also confirmed that the notice was provided to property owners within 300 feet and no comments were received.

Commissioner Reynolds asked for clarification on condition no. 6 concerning possible street improvements based on valuation of tenant improvements.

Motion by Pruitt, 2<sup>nd</sup> by Baca, to close the public hearing and approve Case File No. 2010-02 CUP based on required findings and subject to conditions of approval.
