Water channels and public storm drains were clogged with trash. This prevented the water from the rain to properly clear, which caused the flood. The City of National City failed to clean channels/drains.

My car was totaled by the damaged received by the water/flood I had to rely on Lyft and Car Rentals for transportation. I lost all my personal belongings inside my car and had to buy a temporary car to mitigate my damages.

This number was obtained by adding the remaining debt (\$5765.22) on my car + car rental and lyft (\$261.96)+ a temporary car I purchased for \$1875 + \$3,184 in personal property I had inside the car.

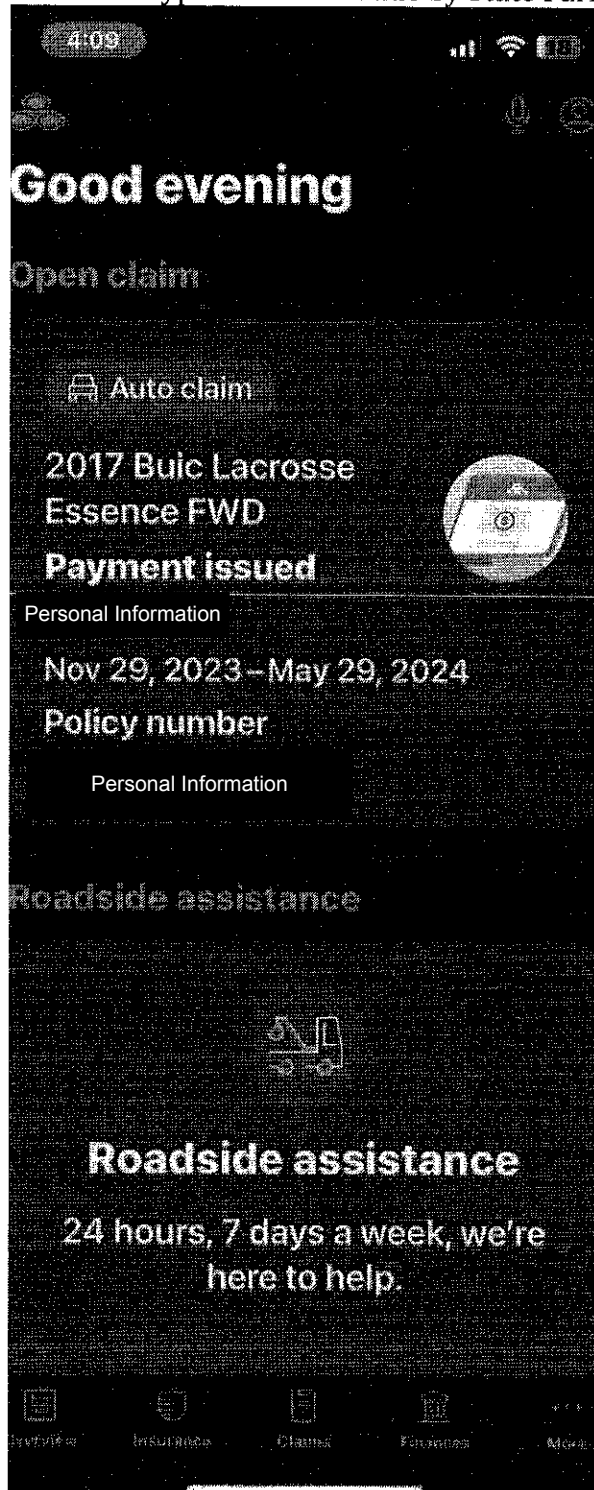

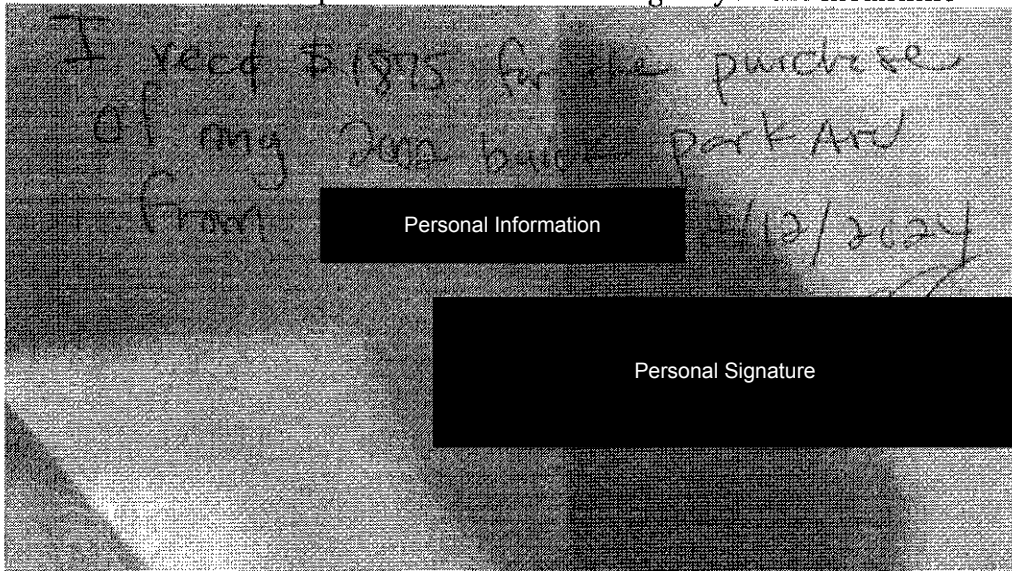
