FREQUENTLY ASKED QUESTIONS REGARDING THE CLAIMS PROCESS

- **Where do I get a Government Tort Claim form?**

Download Claim for Damages to Person or Property Form at www.nationalcityca.gov or you may pick up a claim form at the Office of the City Clerk, located at 1243 National City Boulevard, National City, CA 91950. The City Clerk's telephone number is (619) 336-4228. Also, you can request a claim form be mailed to you via telephone at (619) 336-4300.

- **Does it cost me anything to file a claim?**

No. The City does not charge a fee to file a claim.

- **How long do I have to file a claim?**

Most claims must be submitted to the City Clerk within 6 months of the time the event or incident giving rise to the injury, loss or damage occurred. However, certain types of claims may be filed within 1 year of the date of the event or incident. Additionally, the Government Code provides for other exceptions to the general 6 month period. If you aren't sure whether or not you fall within one of the exceptions, you should contact an attorney. City staff members are prohibited from providing legal advice.

- **What information may I send with my claim form?**

You may provide any information you believe will support your claim. For example, claims are often submitted along with photographs, receipts, estimates or diagrams. Please keep copies of any documents you submit because the City will not return any documents to you.

- **Can I fax or email the completed claim form to the City Clerk, instead of mailing or dropping it off?**

The City only accepts properly completed claims that are either (1) personally delivered to the City Clerk's office, or (2) mailed to the City Clerk's office. The claimant's original signature must appear on the claim form. The City does not accept claims submitted by email or facsimile.

- **What happens to the claim after I submit it?**

The City Clerk forwarded to the Risk Manager for review and further investigation. Depending on the facts or nature of the incident, most claims are processed within 45 days pursuant to the Government Code. You will be contacted if the Risk Manager has questions regarding your claim. If not, the Risk Manager will determine whether to approve, compromise, or deny the claim. The City's final decision will be mailed to the address listed on the claim submitted to the City.

- **What happens if my claim is denied?**

As required by the Government Code, the City provides all claimants (whose claims have been denied) a standard, written response outlining a claimant's legal remedies.

- **Is the City responsible for claims that happen while riding a public trolley or bus?**

Both the San Diego Trolley and San Diego Transit (public buses) are under the jurisdiction of the Metropolitan Transit System ("MTS"). To file a claim against MTS, contact Public Transit Customer Service at (619) 238-0100.

26 **Basis of claim:**

27 Claimants bring this claim against National City in conjunction with their claims against the
28 City of San Diego for the flooding arising from the failed Chollas Creek drainage infrastructure.
Claimants home was flooded and sits within or at the border of National City's jurisdiction.
Claimants believe that some of National City's drainage infrastructure may have caused or
contributed to the flooding that Claimants suffered, but at this time are limited by their ability to
determine the extent of National City's responsibility or the exact infrastructure that caused

1 Claimants' harm. Claimants are limited by the 6 month government claims statute and file this claim
2 to preserve their rights as investigation into the cause of the flooding and the responsible parties
3 continues. Claimants address should assist National City in identifying nearby infrastructure and
4 conducting an investigation into its ownership, maintenance, and use.

5 Claimants were victims of this predictable "unnatural" disaster when multiple government
6 entities failed to maintain and improve their drainage infrastructure. They suffered harms outlined in
7 the damages section below.

8 At this time, the full extent of National City's notice, lack of maintenance, and other acts or
9 omissions forming the basis of its liability are not known. Claimant(s) do not intend this statement to
10 constitute a comprehensive list of the entire basis of the City's liability.

11 Claimants intend to bring the following legal causes of action:

12 Dangerous condition of public property (Gov. Code § 835)

13 Inverse condemnation

14 Trespass

15 Public and private nuisance

16 Violation of Government Code § 12955.8 -- Fair Employment and Housing Act

17 Code of Civil Procedure section 526

18 These causes of action are not all-inclusive, nor are all facts forming the basis for the City's
19 liability known to Claimants at this time.

raining hard; when she went back inside to warm up her coffee, she started hearing people screaming. She went back inside to alert her [REDACTED] of the flood and told them to shelter in place due to being trapped in the neighborhood. Their community is fenced, and fences were not letting her, nor her neighbors evacuate [REDACTED] gave neighbors a saw to cut the fence to evacuate with their cars and she returned home with the [REDACTED] since the water stream was too strong. Firefighters arrived and evacuated [REDACTED] [REDACTED] through a boat around 12 pm. The family stayed at their family member's home for 3 days and was then relocated by the city to a Marina Bay hotel where they stayed for 2 weeks. ECOS relocated the family again to Ramada Inn, but the family requested a change since the living conditions were bad and the family got personal items stolen. The family also witnessed prostitution and were there for 2-3 weeks. ECOS then relocated the family to Comfort Inn in Chula Vista. They then returned home on 06/21/2024 to an unfinished home due to the hotel voucher expiring.
