- The Last Comprehensive Update was in 1996













Mixed Use Zoning

MXC-I and MXD-I

- Creates Minor Mixed Use Corridors and Districts that are Compatible with Adjacent Single Family Neighborhoods
- Minor Mixed Use Corridor Zoning is Designed to Create a Pedestrian-Oriented Form of Development
- Minor Mixed Use District Zoning is Intended to Facilitate the Redevelopment of Large Sites Currently Occupied by Automobile-Oriented Uses





Mixed Use Zoning

MXC-2 and MXD-2

- Creates Major Mixed Use Corridors and Districts that Function as Important Activity Centers
- Major Mixed Use Corridor Zoning is Intended to Create Vibrant and Attractive Places at an Urban Scale
- Major Mixed Use District Zoning will Function as Complete Neighborhoods with Reduced Dependence on the Automobile




Accessory Dwelling Units




