3. Public Hearing – Conditional Use Permit to Allow Gold Buying at an Existing Check Cashing Business at 1539 East Plaza Boulevard. Case File No. 2010-16 CUP.

Commissioner DeLaPaz stated that due to owning property in close proximity to this site, she will be stepping down from her seat for this item.

Commissioner Reynolds clarified that the State law requires purchased gold to be stored for a minimum of 30 days before being resold to a smelter, but the applicant has agreed to extend the holding period for a total of 60 days. The applicant confirmed that he has agreed to hold the items for 60 days.
