Recreation Centers

For the last week of summer camp, participants took a trip to National City's Heritage Square and Morgan Square and toured the historical buildings and public art there. In August, we also partnered with the SD Rep for our "Take the stage" week. The Rep brought in some actors to teach improvisation games to all 60 summer camp youth. Youth also got a tour of the National City Arts Center.

Teen Center

The teen center took two trips in July past month. They went to the SD Rep's production of "Hairspray" as well as a Padres game. They also went on a field trip to Soak City in August. There were 201 participants at the teen center in July and 195 participants at the center in August. The fitness center is almost complete upstairs in the teen center.

Junior Achievement

Summer camp youth participated in the Junior Achievement program for the last two weeks of camp. Junior Achievement is a free program that promotes financial skills and competency to our 3-6 graders. Teen center staff was trained to implement the junior achievement program for high school level youth in August.

Flyers

We have had trouble getting the National School District to approve our afterschool program flyers. They denied our request to send flyers out to the schools because they provide an afterschool program to the youth of National City. In addition, we are partnering with the Barnes Tennis Center to provide the youth of National City with a low cost tennis program at Las Palmas Park. The program will cost \$6 a week. Flyers were sent to the National School District and denied as well.

- Our annual Rummage Sale was on Saturday, September 11th was a huge success with over 20 selling tables in the senior center parking lot.
- The Kimball senior center began closing on Fridays on August 27th.
