2. Continued Pubic Hearing – Conditional Use Permit for live entertainment and Zone Variance for less than required parking at an existing bar/restaurant at 105 E. 8<sup>th</sup> Street (Case File No. 2010-33 CUP, Z).

Charlton Adler, Ben Adler, P O Box 2885, National City, applicants, stated that they have read and understand conditions of approval and would like Condition No. 10 regarding hours of operation amended to be from 7:00 p.m. to 1:00 a.m., not 6:00 p.m.

Mr. Adler responded to Commissioners questions concerning parking and live entertainment.

Tom McBride, 115 E. 8<sup>th</sup> Street stated that although he previously opposed the use, due to parking; parking is not an issue in the evening, and he can now support the application.

Alex Baldwin, Vee Auto Parts, 704 A Avenue, spoke in support of the application.

Jack Armstrong, 801 National City Boulevard, #1010, stated that Mr. Adler has addressed many of the issues, and the restaurant will help with security.

Commissioners discussed adding a sunset clause or review condition to the conditional use permit. Staff stated this is already addressed by Condition No. 15.
