4. 1810 E. 22nd Street – discuss Las Palmas Park
5. 1415 E 4th Avenue – discuss Granger Music Hall and 4th Street Community Corridor
6. 923 A Avenue – discuss Kimball House, 921 and 929 National City Blvd
7. 148 E 12th Street – discuss Kimball Park and Centro Condo Unit
