Council Member Zarate reported that the members of her Old Town Reunion Committee were very special and everyone will be surprised with the fantastic event that has been planned.

Mayor Morrison said it has been a great week with the swim event, movies in the Park and the Stein Farm and coming up will be the OTNC Reunion and on September 22nd the 125th Anniversary picnic. The Mayor explained the background and recent events with the State of California demanding an immediate payment of \$4.3 million from National City and the expected additional demands and consequences for the City and the State.
