3. Public Hearing – Conditional Use Permit for an auto detailing business in the Westfield Plaza Bonita Parking structure located at 3030 Plaza Bonita Road. Case File No.: 2012-17 CUP.

Comments by Applicant: Nahum Peralta, 2934 E. 10<sup>th</sup> Street, National City. Applicant gave a detailed description of how the business works using steam to clean the interior and exterior of the cars. He answered questions posed by the Commissioners regarding overspray, noise, employees, noticing, toxins, parking issues, and possible interference with the transit route.

Comments by Daniel Guadarama: 2030 E. 16<sup>th</sup> Street, National City.
